

PLEASE READ CAREFULLY
WAIVER AND RELEASE OF LIABILITY

In consideration of the GREEN RIVER PADDLE TRAIL furnishing services and/or equipment to enable me to participate in river activities, I agree as follows:

I fully understand and acknowledge that: (A) Risks and dangers exists in my use of canoeing equipment and my participation in river activities. (B) My participation in such activities and use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability. (C) These risks and dangers may be caused by negligence of participants, the negligence of others, accidents, and the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; (D) by my participation in these activities and/or use of equipment, I HERBY ASSUME ALL RISKS AND DANGERS AND ALL RESPONSIBILITES FOR ANY LOSSES AND/OR DAMAGES, WHETHER CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF OTHERS, CONDUCT OF OWNERS, AGENTS, OFFICERS, OR EMPLOYEES OF THE GREEN RIVER PADDLE TRAIL OR BY ANY OTHER PERSON.

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify GREEN RIVER PADDLE TRAIL, GREEN RIVER CANOES, THE CITY OF GREENSBURG, AND IT'S EMPLOYEES, owners, agents and officers from any and all claims, or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of CANOEING OR KAYAKING EQIPMENT or my participation in RIVER ACTIVITES. I understand that I am releasing, discharging, and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of the GREEN RIVER PADDLE TRAIL.

I HAVE READ THE ABOVE WAIVER RELEASE AND BY SIGNING IT AGREE: IT IS MY INTENT TO EXEMPT AND RELEASE THE GREEN RIVER PADDLE TRAIL FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.

I authorize any medical treatment deemed necessary in the event of injury and have appropriate insurance or agree to pay all costs of rescue and/or medical services as may be incurred. I agree to any film or photographs of me/us as participates become property of Green River Paddle Trail. I agree to pay for any and all lost equipment.
